after this deadline will be rejected.

Bids must be valid for a period of 90 days after bid opening and must be scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of Rs.1,65,000.00, which shall be valid for 30 days beyond the validity period of the bid.
