5. Electronic bids must be submitted to the office **Putalibazar Municipality, Syangja** through PPMO website [www.bolpatra.gov.np/egpon](http://www.bolpatra.gov.np/egpon) or before **12:00** on **2020-07-05**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 on 2020-07-05** at the office of **Putalibazar Municipality, Syangja**. Bids must be valid for a period of **90 days** after bid opening and must be scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **Rs.1,25,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
